BROOKLYN POLICE DEPARTMENT HAS EXHIBITED A PATTERN OF POLITICAL ABUSES BY AND THROUGH POWERS USED TO DEPRIVE ME AND MY KIDS OF EQUAL PROTECTIONS UNDER THE LAW. BROOKLYN POLICE OFFICERS ENGAGED IN RECKLESS PATTERN OF GIVING LEGAL ADVICE TO CRIMINALS TO PREVENT THEM FROM BEING HELD ACCOUNTABLE. BROOKLYN POLICE DEPARTMENT DELIBERATELY LIED TO THE OHIO ATTORNEY GENERAL'S OFFICE TO EFFECTUATE A FRAUDULENT ENDANGERED MISSING PERSON AND ENDANGERED CHILD ALERT AGAINST ME AND MY KIDS. BROOKLYN POLICE DEPARTMENT IS A RACKETEERING INFLUENCE CORRUPT ORGANIZATION IN ACCOURDANCE WITH 18 U.S. Code Chapter 96 - RACKETEER INFLUENCED AND CORRUPT ORGANIZATIONS.

TO EVERY ORGANIZATION UNDER THE SUN THAT BROOKLYN POLICE DEPARTMENT, DONALD MCMAHAN, TIMOTHY BROWAND, AND JEANINE COAKWELL HAVE MADE FALSE REPORTS OR ENGAGED IN RICO ACTS WITH IN REFERENCE TO MYSELF, DIANNA HILL I DULY NOTIFY THAT THEY WERE DECEIVED BY AND THROUGH TIMOTHY BROWAND'S LIES.

DIANNA HILL DULY NOTIFIES YOU THAT YOU HAVE BEEN DEFRAUDED BY THEIR ACTIONS AND FRAUDULENT STATEMENTS. THESE PERSONS ENGAGED IN A PATTERN OF RICO THAT HAS EFFECTIVELY VIOLATED ME AND MY FAMILY/CHILDREN WITH FALSE, INFLAMATORY AND FRAUDULENT INFORMATION. THEIR DEVISIVE ACTS USED TO ABUSE MYSELF, TO SHUT DOWN MY BUSINESS, AND STEAL MY CHILDREN AND ESTATE ARE CRIMINAL.

FACTUAL EVIDENCE IS AVAILABLE THAT PROVES EVERYTHING THAT I SAY. THEIR "one incident" THAT HAS BEEN MISUSED TO GAIN LEGAL ADVANTAGE, TO MISINFORM INVESTIGATORS, AND DEPRIVE US OF EQUAL PROTECTION UNDER THE LAW IS CULPABLE.

For the Record: I, DIANNA HILL, am mother to three minor children who I love, adore, and work fiercely to protect. I, Dianna Hill, am NOT declared mentally incompetent by any court. I, Dianna Hill, do not have a warrant for my arrest. I, Dianna Hill, do not have an Amber Alert issued for my children. I, Dianna Hill, do not have post partum depression and never had it. I, Dianna Hill, broke up with Timothy Browand on July 24, 2017. I, Dianna Hill, and my children; have been abused by the acts of DOMESTIC VIOLENCE, THEFT, AND FRAUD purported by

Timothy Browand that have rippled across our country. WE WERE ILLEGALLY EVICTED AND INTIMIDATED OUT OF OUR HOME ON 9/7/17 BY TIMOTHY BROWAND AND DONNIE MCMAHAN. I, DIANNA HILL, SOUGHT REFUGE IN ANOTHER STATE TO ESCAPE THE HABITUAL ABUSE, FRAUD, LIES, AND SLANDER EFFECTUATED BY AND THROUGH TIMOTHY BROWAND. I, DIANNA HILL, HAVE DONE NOTHING WRONG EXCEPT LEARN THAT MY EX HAD INTERESTS OTHER THAN ME WHICH WERE OUTSIDE OF MY BOUNDARIES AND I CHOSE TO LEAVE THE RELATIONSHIP. I WAS MET WITH DOMESTIC VIOLENCE AND A PERPETUAL MOTION OF FRAUD BY AND THROUGH TIMOTHY BROWAND'S ACTS TO DATE THAT CONTINUE TO VIOLATE ME AND MY CHILDREN.

On Thursday afternoon, 9/7/17 while trying to move out by the weekend; we; me, Dianna Hill, and my children were ILLEGALLY Evicted out of our home without cause, warning, due process, or valid reason. We were intimidated out of our home with the threat of the police removing us by 6pm if we were at the home when Timothy Browand arrived there after work on Thursday, September 07, 2017 by both Timothy McMahan and by Donnie McMahan (My Uncle, Timothy Browand's Boss and the Landlord/owner of our home.) This occurred via two separate speaker phone calls exchanged while I was already packing up my stuff to move out. Yet, at that moment; we were made to fear for our lives by the threat of Donnie McMahan citing that if I had said something derogatory about him that he would kill me on 9/7/17 at approximately 3pm. This act to induce panic, subject Dianna Hill to reflections of acting inappropriately, and create an environment that permitted Timothy Browand and Donnie McMahan to control the flow of information to and from all investigators from that day forward was completely reckless. The intimidation to "NOT GO THERE" by Donnie McMahan to myself on that day, when I debated that this was illegal; was very real. He had no remorse, no care, and no emotion about forcing me and my three kids to leave the home with no plan and no resources on hand at that very moment (at least in their minds.)

It is funny that -my millionaire uncle- effectively forced me and my kids out and didn't offer an ounce of help... Of course; the same man evicted two of his adult children and all of his grandchildren from homes he owned as well. At least they got proper notice through the courts.... But, I didn't even get that.....

My buddylist

Between August 2, 2017 and now; there Donnie McMahan is telling the world that I have PPD and that I have chemical imbalances. I guess he is an MD and the truth sent him into a cycle of cover up.... at my cost. His acts are reckless and negligent. His eviction has caused a chain of events in my absence that will never be made right. His acts to help cover up the abuse we sustained created more undue hardship and unnecessary stress at unreal levels. These acts were illegal, malicious, deliberate and effectively created harm to me and my children in the middle of other domestic violence events. Then; he communicated with the police and lied to them about me. He disdains me; even to my face. I have lived with his personal opinions adversely affecting me for years. This is nothing new. I tried confronting him about it in 2015 and coming to a peaceful status with him. That was the worst mistake of my life. Thereafter; he only used that moment to figure out all of my vulnerabilities, assets, and work to violate me by and through Timothy Browand; his "right arm man."

Donnie McMahan HATED me. I heard it from several people in recent years; including Timothy Browand. Timothy Browand has worked for Donald McMahan for approximately 13 years. Timothy and I had a relationship between September 18, 2015 and July 24, 2017. The relationship had tons of dynamics and issues that resulted in our ultimate break up in July 2017. Those issues began to unravel thereafter including the fact that I went to the Brooklyn Police Department and requested an intervention to the chronic incidents I was redressing with Timothy Browand; particularly concerns that created a completely insecure situation in our home and shut down my ability to work, interfered in my work and destroyed my ability to earn money independently. (AKA: FINANCIAL ABUSE).

Donald McMahan would not even allow me on the premises of McMahan's Auto Wrecking to visit Timothy Browand at work. Timmy yelled at me regularly for stopping in for a five minute visit intermittently. Anytime I stopped there; I was not allowed to be there more than 10 minutes or so ever. Despite Timmy being there for 60 hours a week and never getting a lunch break. Timmy would rush me out of there in fear of Donnie flipping out of him even for just dropping off a bag of food for my ex to have lunch. Donnie McMahan knew that Timmy and I broke up in July. I had went to him on August 2, 2017 and borrowed \$500 to get a new phone and start networking to do the move out of my household stuff throughout August 2017. He told Timothy Browand everything and caused me further instability and backlash in the home between then and now by Timothy Browand. Everyone knew that we were broke up and that I was moving out.

Between July 24, 2017 and the date of 9/7/17; the problem became that Timothy Browand kept threatening to take my kids if I moved here or there. He intimidated and threatened my parenthood with his methods to control where I moved and who could be around my kids. He had an excuse for everything. Timothy Browand was NOT helping me to exit; he was causing me undue harm with my efforts to separate our relationship for weeks. His interference in my efforts to move out was unlimited and underhanded. The additional stress was unnecessary. At one point;

Timothy Browand threatened to go down to Lake Erie Edgewater and blow his brains out if something came to be true.

I tried everything to keep it civilized, to react to the issues at hand with a level head, and to be mature about our dissolution of relationship. I tried talking to him; he shut me out. I tried being calm; he threatened me. I tried keeping my cool; he would pull stunts like call me on the phone and say nothing for long periods. I tried not telling him what I was doing; he would go berserk. I tried mostly to protect my children and eat shit and avoid filing a DV charge on him because the ramifications would mean tons of problems.... His bouts of violence resulted in a beer bottle smashing against the house, him backhanding his 14 year old son, Tristan in the sternum into a wall so hard that Tristan fell to the floor, and Timothy Browand flipping out on my 15 year old daughter in a completely lacking self control, terrorizing way which traumatized my daughter on 9/4/17. Yet, the police didn't want to document those reports and incidents. They were too busy railroading me in collusion with Timothy Browand and Donald McMahan. Their misinformation to the world and slanderous false allegations that I had PPD and a chemical imbalance resulted in the railroading of the century. Who was supposed to protect us? We left and their lies perpetuated and dismissed all of our experiences as untrue and retaliatory. I had no reason to retaliate against them until I learned the lists of facts that occurred and were cited in my absence.

The thought of disrupting Donnie McMahan's world by effectively putting Timothy Browand on the hot seat for his actions was a scary situation. Having my phones disabled by Timothy Browand to falsely imprison me and prevent me from getting assistance was also wrong. I tried calling the DV people, to call for help. My calls were not going out. Timothy Browand is his right arm and the backlash was not good.

The worry that if Timothy Browand got a DV charge because I reported it; would result in jail time and cost him his job, his home, and his ability to pay child support was real. The threat that a DV case would create a ripple effect of negativity in all directions, particularly with our families; was tremendous. I lived in fear for weeks while trying to relocate me and my children in an amicable dissolve.

My own brother and his family and their livelihood was on the table as they use the McMahan's auto wrecking resources for their own needs daily. They were misled by Timmy's acts too. He didn't even involve them in his acts that occurred behind my back. It took everything I had to go to the police on September 01, 2017 and beg the officers to go talk to Timmy and tell him to pump his brakes long enough for me to be out by the following weekend. I begged them to help me deescalate things politely. I advised them that I JUST WANTED OUT but was so overwhelmed with weeks of abuse that I needed intervention. Their intervention destroyed my life. The Brooklyn Police Department said that they could not help and this case was above their pay grade and referred me to the FBI. I reported it to the FBI. They told me that it was civil and that if I had concrete evidence to bring it back. Everything I had was made inaccessible to me thereafter by and through the acts of Timothy Browand, Donnie McMahan, Jeanine Coakwell, and the Brooklyn Police Department. The world will never know the depths of the truth. The unknown questions will remain about how far this entire matter extended. All I do know is that I stepped on a bomb in this case of getting involved with Timothy Browand. His list of ex wives can attest to his history of head games, deviant behaviors, and devilish acts that destroyed them during dissolutions.

The Brooklyn Police Department had been duly notified by myself on the morning of 9/7/17 that I was there to move my stuff out of the home and get my kids somewhere safe. Instead; we were forced out with nothing but what we could carry in a car under the threats and intimidation faced above. The police report and the body cams would show my state of mind and comments that validate this fact; but I am positive that they will disappear too.

I walked out on 9/7/17 with threats to my existence.

I NEVER have been able to regain direct possession of anything I own thereafter to date. Timothy Browand moved my personal effects into an unknown storage unit location and refused to give me possession of my belongings. He attempted to coerce me back home to regain possession of everything. I told him on and others on many occasions that I wanted NOTHING to do with any kind of interactions directly with him, particularly regaining my life. I tried to call Brooklyn PD to file a police report on this subject of his theft; they said it was civil. The next day; Timmy decided to agree to using a POA to exchange possession and ownership of my stuff back to me. That took weeks to execute.

Timothy Browand still refuses, to date, to give me my children's furniture, their personal belongings, and my business computer, my father's heirlooms from his military estate, and much more. The police say that this act is "Civil."

Timothy Browand refuses to give me access to my Verizon Cloud with almost 18,000 pictures on it.

Timothy Browand refuses to give me access to my Verizon Telephone number and account that I sustained from January 2016-September 12, 2017; despite him removing my ability to use the phone on September 05, 2017 via parental controls on Verizon and thereafter completing shutting the phone off on 9/12/17. In

addition; he deleted over 400 contacts off of my Verizon Cloud and off of my telephone itself; leaving me without a way to contact anyone in the days around 9/6/17. Timothy Browand abused me and my kids with these acts. Brooklyn PD didn't see any black eyes; so we did NOT get protected in this matter.

Basically I lost my entire LIFE that day. Timothy Browand, Donnie McMahan, and the Brooklyn Police Department controlled it all. I chose to put our safety above everything and leave under said duress. Yet, after all is said and done.... the perpetuated lies after I left Ohio are reckless, full of holes, and reflect corruption, collusion, and racketeering beyond the scope of anyone's imagination.

The Brooklyn Police Department had a duty to protect us; they did not. They had a duty to take my police reports; they did not. They had a duty to document witness statements; they did not. They spent lots of time working to discredit me to countless investigators and to protect the criminal acts of Timothy Browand so that he did not catch a Domestic Violence Case. This police department overextended their reach in so many ways that our lives have effectively been destroyed.

I will never stop fighting for Justice. I will never understand how the good ole boys network of Brooklyn Ohio could go so far on behalf of Timothy Browand and Donnie McMahan; but I guess that I don't have any favors to pull in Northeast Ohio to get protection in this matter. As a matter of fact; every scream for help that I made was DISMISSED by everyone because of Brooklyn Police Departments perpetual fraud to everyone citing that I was declared Mentally Incompetent by the Cuyahoga County Probate Court and that I was crazy. This in fact is a fraudulent case. Brooklyn Police Department's acts are still causing a ripple effect on me and my children's lives that have yet to be assessed and the perpetual motion of citations by professionals that all of this is: CIVIL; means that we'll be in court for years like the Tamir Rice Case getting justice.

Instead of getting justice in the beginning; we got Brooklyn Cops playing GOD with our lives....There is no protection for victims of Domestic Violence in Brooklyn, Ohio. Don't let the Brooklyn PD know where you are at or they will put it on the news too. I was a victim of DV who fled Ohio to find safety and respite upon exit. The Brooklyn PD colluded with my perpetrator to make false police reports, to create a fraudulent Endangered person alert, and worked to help him hunt me down using their powers that be within the State of Ohio legal infrastructure. This was by and far the furthest overreach of power I have ever seen in my life.

You cannot expect the Brooklyn Police Department to do the right thing. They play dirty. Today; I am certain that all of those police reports, body cams, and witness statements--mostly made unavailable to myself during a public records request; are going to disappear.

Apparently; Brooklyn PD allows persons to file fraudulent police reports, despite knowing facts that dispute those statements. They help criminals get away with crimes. They do not protect women and children and particularly those who are scared to death. They simply help steer you out so that they can help obstruct justice and clean up the possible evidence of crimes. Then, they tell all other investigators that the person making the reports is "Crazy" and they "Dismiss" all investigations. They use the cover of their badges, their positions, and their political pull to steer other investigators off the trail. They keep command and control of investigations so that others do not get involved in matters like this that require assistance from other agencies. Brooklyn Police Department decides who gets help and who does not. They decide who gets protected and who doesn't. It's a pay to play world and only those who can scratch each other's backs matter. Of course; those with years of vested pull get that positioning....and of course that was not me in this matter.

I spent a lifetime having character, integrity, honor, and moral turpitude that was impeccable. My love for my family, my country, and my community have been exhibited and put on front street earning high accolades throughout my life. I am brash; but truthful. I have nothing to hide. I have boundaries and I wanted out of a relationship that was toxic to my existence. I asked for help and got railroaded with lies and abuse.

The matters of our case included Domestic Violence that we suffered by and through Timothy Browand's controlling everything including police investigations, what people knew about the internal details of our homestead, the fear, the intimidation, the threats, the everything. We lived in fear and I was isolated from other persons that could help me. I begged for help from my family and friends trying to escape the household with three children between July 24, 2017 and September 07, 2017 when I finally completely left the state to seek protection and started a new life and felt safe hundreds of miles from their reach; I got hit with the reality of snowball effects which rippled from this fraudulent man after I had left; unbeknown to myself.....

So many people are afraid to speak up because "GODLY" Donnie McMahan is at the core of it all.

Donnie McMahan and Timothy Browand colluded with Brooklyn Police Department to downright defraud the public at large and violated my person with lies and misinformation over part of one incident---missing thousands of other incidents. Their lies live; but life is destroyed.

Now I know deeply; why women who are victims of Domestic Violence are so afraid to go to the police.

I went to the Brooklyn Police Department on September 1st 2017 to request help and I begged them for discretion in matters of great concern to me and my children's safety and security. I was terrified at what had been going on for weeks. I needed help to figure it out and stop the interruptions that were disrupting our lives. They said that my request for help was "Above their Pay Grade" and sent me in a tailspin that has effectively destroyed me and my children's lives. They are wrong for not protecting me and my children. They are wrong for causing irreversible damages. They are wrong for failing to investigate. They are wrong for subjecting us to criminal activity that including empowering criminals to evict us with a threat of being removed by the police. They are wrong for skewing the information on police reports in reference to events that occurred and neglecting to document other witness statements. They are wrong for giving legal advice to persons. They are wrong for deliberately choosing to obstruct justice. They are wrong for helping someone clean up a crime scene. They are wrong for helping someone steal everything that I own. They are wrong for not investigating the original claims. They are wrong for telling the culpable parties about the things that I cited in my police report, under the gamut of, "The good ole boy network." Brooklyn Police Department created a chain of events that has rippled across several states; dismissing the truth because of their very own perpetual fraud. The Brooklyn Police Department lied to countless other investigative agencies to discredit the truth. They didn't write witness statements or document the truth of events on their body cams. They misrepresented facts to the Ohio Attorney General, allowed the criminal to make false police reports, and they completely violated the Violence Against Women Act by partaking in criminal activity that has disrupted me and my family.

The Department of Justice needs to investigate Brooklyn Ohio Police Department for their negligence, abuse, and failure to protect me and my family from abuse that was sustained in our household. They have unilaterally attempted to dismiss every truth with further fraudulent statements in a deliberate attempt to cover up their own mistakes. This is unconscionable. Their acts have resulted in so many lineal events that deprived me and my children of our due process rights, of our civil rights, and of our constitutional rights; that justice will never be served. They helped "clean up" evidence and put me in a position to leave the state seeking refuge elsewhere with my children and then they exposed that location on the news. They are culpable and wrong.

Where are your black eyes? I didn't have any.... so, they sent me to the FBI. What an idiot I was. The entire reality is that my exit was not soon enough and by the time I left; the powers that be had been working tirelessly in the background to "DISCREDIT" my very character, integrity and mental status. The first thing that I told the cops "NOT" to do; they ran and did. Their actions empowered criminality to exacerbate while depriving me and my kids of Equal Protection under the law. The immeasurable unnecessary stress survived to date from the chain of events is unreal. Brooklyn was so busy helping protect him that they didn't document true moments and what they did document was slanted so as to protect him. Thanks be to God for the Good Ole' Boy network of Brooklyn Ohio with the Brooklyn Police Department.

What followed-will forever have changed me and my family's lives at large. The reflections of corruption, collusion, covering up, protecting the violator, and assisting him in obstructing justice have been surreal. The reality is that the good old boy network of Brooklyn, Ohio is alive and well. Politics, power, and professional misconduct can really destroy lives to protect culprits.

The perpetual fraud by and through Timothy Browand, Donnie McMahan, and The Brooklyn Police Department has resulted in CCDCFS being lied to and misrepresenting facts in testimony and creating an adversarial relationship with myself because of their unprofessional acts in violation of our rights under DV/VAWA. The CCDCFS represented allegations made strictly by Timothy Browand and persons I have chose to remove from my life because they were so glued to Timothy Browand's fraud. His manipulation of persons has resulted in extraordinary levels of "FAILURE TO PROTECT THE BEST INTERESTS OF ME AND MY CHILDREN."

We moved away. I realigned our lives. My children are attending school. We are stable. We have are living in a loving, stable home full of abundance, amenities, and resources. We want not for anything. Despite leaving with nothing; we arrived to abundance. We want not and need not for anything. Our lives were stable, healthy, and happy. As usual; I took care of all of my parental responsibilities without worry. I got them new providers and attended to tons of appointments. I got aligned with the DV resources, sought assistance and used referrals to take care of everything. I am not incompetent. I am a great mother to my children.

I refuse to be lied about and have my parental rights interfered with in consideration of all the facts of perpetual fraud which were presented in a manner so as to challenge my parental abilities.

Timothy Browand's fraud continues in the Cuyahoga County Juvenile Court where he and his Attorney filed a FRAUDULENT UCCJEA AFFIDAVIT, A FRAUDULENT APPLICATION TO DETERMINE CUSTODY, and they filed a FRAUDULENT MOTION

FOR TEMPORARY EMERGENCY CUSTODY OF MY CHILDREN in my absentia. I got the summons in KS on 10/30/17 for a hearing in Ohio slated for 10/31/17 at 1:30pm. Again; the violations to my rights ensued.... attached is almost 500 pages of evidence that show the history again and again as I sit here fighting for this case of perpetual fraud to be stopped. I have had to go to the KS courts and get a Protection From Abuse Order of which he purported his lies to this court and cited that the acts were retaliatory.

The research shows that Attorney John Lawson committed Attorney Misconduct, the Magistrate did not protect us in consideration of the duly noted abuses on 11/15/17; and then their misinformation that was noted in the transcripts but not the 11/15/17 order were reckless and refused to acknowledge the TRUTH. Instead; it's all driven by the fraud that Timothy Browand and Attorney John Lawson falsely used to induce panic in the Cuyahoga County Juvenile Court. Magistrate Lynne Chavers had the opportunity to stop this act which is like a parental kidnapping of my children to force and intimidate me to return to Ohio by legal measures of Timothy Browand. Later, I found out that CCDCFS was SUBPOENA'd and they had never filed anything to take my parental rights. Yet, one of their workers allegedly told Timothy Browand to seek custody of my children; the ones I told her that I was trying to protect from his abuse.

Well, I guess she got taken for a ride of his fraud too. She must have been the one who asked me if I was still hearing voices? I told her to let me talk to her supervisor because it was above her pay grade in this matter of perpetual fraud and that she had been unprofessional to me. We had an adversarial exchange back around 9/19/2017....

Over 4 weeks later; and after me and my kids had relaxed into our new lives without him; Attorney John Lawson went and filed this fraudulent package that I dispute, object to and was unable to have legal representation to defend for a list of reasons. I was left up against a wall in a hearing that presented fraud after fraud with their false allegations. I was railroaded after being denied a continuance. I did not have the pleadings available to myself. During the hearing which they allowed me to attend via phone; I started hearing all of those things that invoked PTSD of the abuse sustained to date. YES, I went and got a PFA immediately thereafter due to the extraordinary level of fraud revealed by and through this action. I was left defenseless and without help to date. The magistrate said that I could file objections in the matter if I came to the court. The private petition by Timothy Browand (our abuser) was represented as though it was an active emergency and the lies rolled out. At the second hearing; the magistrate was notified that a list of documents were invalid, that the representations made to the court were inaccurate, and she refused to offer another method to allow me to submit said evidence to stop this action of taking my children. She failed to protect us on so many levels; she should NEVER EVER BE ALLOWED TO SIT ON A BENCH ANYWHERE EVERY AGAIN. My head still spins enumerating the unconscionable choices she made in being a magistrate.

I have only begun to file my objections and motions to dismiss this case while providing hundreds of pages of evidence that reflect the evolution of this case and the perpetual motion of fraud. The exhaustive work requires truth and justice to prevail in an unbiased forum. My character, integrity, and honor are all being challenged. My competence as a human being is being challenged. I am very competent to fight fiercely for the best interests of my children now that I have learned about all of the wrongs that occurred after I left Ohio.

Attorney John Lawson knowingly misrepresented facts to gain a legal advantage with the Cuyahoga County Juvenile Court. His acts to file said items and present them in such a fraudulent matter to a court is ATTORNEY MISCONDUCT that should result in his license being suspended by the Ohio Supreme Court for violations of the Civil Procedures and for Professional Standards violations.

In accordance with UCCJEA; I sought to have Temporary Emergency Jurisdiction moved to KS where I could actually have retained legal counsel through the local Legal Aid; but that was denied because Timothy Browand said that I was retaliating against him. I was not. I was fiercely fighting to protect my children from further abuse. The court in KS was again violated with the perpetual fraud of Timothy Browand's acts and was forced to "respect the magistrate's decisions as "Godly"; despite pending objections. Therefore, the KS court and Ohio court left it in Ohio because the Objections had not been filed regarding the Attorney Misconduct.

In accordance with Section 208 of the UCCJEA; I ask the Cuyahoga County Juvenile Court to DECLINE JURISDICTION and CLOSE THEIR CASES AND EXPUNGE THEM IN THE CUYAHOGA COUNTY JUVENILE COURT FOR ACTS OF UNJUSTIFIABLE CONDUCT BY ATTORNEY JOHN LAWSON AND TIMOTHY BROWAND. I ask KS to add this case to the Protection from Abuse case as requested last week via a reconsideration of facts.

In accordance with RICO laws; I ask the DOJ to investigate and the OAG and the OHIO SUPREME COURT to investigate. I speak immeasurable truth. We deserve protected from further abuses of a contested Magistrate's order that was created based on FRAUD. I have compiled almost 500 pages of evidence and have yet to begin my legal defense to have my custody restored.

I am ready willing and able to subpoena hundreds of witnesses in my defense. This court needs to help me streamline the perpetual fraud to protect me and my children. I asked for a TRO and the holiday was used as an excuse in a case with exigent circumstances. Apparently my files got the CUYAHOGA COUNTY SHUFFLE... but I have time stamps that say they were received in a timely manner so has to of been effectively processed. This Cuyahoga County Corruption cycle continues and Cuyahoga County Juvenile Court's inability to upright a wrong of horrendous implications is but another reflection of their lack of oversight. I know of other cases that caused irreparable harm by and through CCDCFS and CCJC as recent as this year. They all fight for justice with no oversight in a system that is "Overwhelmed" according to the media.

I, Dianna Lynn Hill, am the mother of ANGELINA, LIBERTY AND JUSTICE. My children are a reflection of my amazing identity. I pray for the community at large to stand up and demand justice in these matters.

BTW: I did file Motions for Dismissal, MOTIONS FOR TRO, MOTION FOR INJUNCTIVE RELIEF, MOTIONS FOR INTERVENTION, MOTION FOR TEMPORARY EMERGENCY JURISDICTION TO BE MOVED TO KS, MOTIONS FOR ATTORNEY JOHN LAWSON TO BE DISALLOWED FROM PRACTICING IN CCJC, AND FOR MAGISTRATE CHAVERS TO BE RECUSED FROM MY CASE DUE TO THE LEVEL OF PERPETUAL FRAUD THAT CREATED INSURMOUNTABLE BIAS BY AND THROUGH HER ACTS THAT VIOLATED US.

ATTORNEY JOHN LAWSON FAILED TO CITE THAT OTHER CHILDREN IN TIMOTHY BROWAND'S CUSTODY HAD BEEN MOLESTED AND RAPED AS A RESULT OF HIS PARENTAL NEGLIGENCE HISTORICALLY. THEY FAILED TO CITE THAT HE HAS A HISTORY OF DV, CONTEMPT AND CRIMINAL CONVICTIONS. THEY MISREPRESENTED HIM AS A SHINY PENNY AND DEFRAUDED THE COURT. THAT VICTIM CONTINUES TO SUFFER FROM THE PTSD THAT SHE SURVIVED IN TIMOTHY BROWAND'S HOME. DISMISSING OUR ALLEGATIONS AS RETALIATORY IS NEGLIGENT OF CCDCFS. I DO NOT TELL LIES. I submit this report with REALNEO and expect that the nearly 500 pages of my investigation and the results will put a lot of persons in Ohio in investigation and "cover their ass" mode. I appreciate you all ruining my life via fraud. I come from a military background that requires accountability and I expect that all of you professionals will upright your wrongs along the line. Yet, for now, I must go be with my children and try to enjoy this day.... Happy Thanksgiving.

BTW: Detective JOE T. with the Brooklyn PD and the Chief's office; thank you for your failures. I feel so blessed to know that I am competent enough to let the entire world know just how unprofessional you all really are about how you handled the matters that I came to you and requested help with regarding your buddy Timothy McMahan. Thanks for showing the entire world how amazingly corrupt you all can be.... I appreciate the fact you were not man enough to upright your sinking ship back in September.... it is a reflection of your poor character and absolve to protect a criminal.


I enjoyed a nice conversation with a Senator about all of this recently... Truth and Justice will prevail.

YOU ALL ENGAGED IN VIOLATING MY FAMILY AT LARGE.

I apologize to all of the ethical, objective, and professional folks who were misled by Timothy Browand in their investigations.
